

# GTUSD PTO Meeting Minutes

- I. Call to Order 2:55pm
- II. Approval of minutes from last two meetings- *Motion to approve made by B. Poulson, Second by C. Fanning, all approved, motion carries*
- III. Treasurer's Report –*Motion to approve made by C. Fanning, Second by S. Lyons, all approved, motion carries*
- IV. Open Board Position VP Fundraising – *Tracy Hanks made a report that there was an open board position of "VP of Fundraising" There were no interested parties present.*
- V. Amend Bylaws: Sections 4.3.1 and 4.5 make margins and font match the rest of the document. Section 6.9 eliminate last sentence. Section 7.1 change \$1,00.00 to \$1,000.00. *Motion to approve said changes to bylaws made by B. Poulson, Second by C. Fanning, all approved, motion carries*
- VI. Ongoing Business
  - a) District Advisory Vote *A ballot was passed out to all members to approve the "District Advisory Committee" All votes were cast and ballots are to be returned to the District Office*
  - b) Survey Results: 35 turned in –*2015-16 Survey results were discussed. The survey was sent out to all GTUSD Families to see where families want to see PTO money go. 5% were returned. Classroom accounts and science got the most votes with 82 and 79 respectfully. Followed by Healthy Lunches with 69, Technology 67, and Music 63. The other categories were Sports, Playground, Art Supplies, After school enrichment, Beautification, Garden, and PE. All with between 41 and 53 votes. It was discussed that PTO would take these survey results into consideration when considering fundraising spending.*
  - c) Box Tops Progress- 2326 as of 9/27/15 *The Box Tops Competition helped to bring in a record number of Box Tops. It was discussed that having a competition was a good way to motivate kids to turn more in.*
  - d) Pancake Breakfast Report - *The pancake breakfast is this weekend. The following topics were all discussed. As discussed at the previous meeting app proceeds will go towards GTUSD Technology and that teachers will be given a \$25/hour classroom incentive to help at the breakfast*
    1. We have 5-7 teachers signed up for each hour. *Report only*
    2. Pancake breakfast for the class at each school that has the most attendance
    3. More ways to get the word out? *More signage at the school and an additional flyer to be sent home*

4. Advance raffle for anyone who can't come? Raffle carnival wristbands? \$1 per ticket and for every 50 tickets sold we will add another wristband to be raffled. *Discussed and decided there was not a need for a raffle*
5. How many people do we expect? How much food to buy? Hooverville will give us fruit for \$1.50/lb. *At least 100 people are expected*
6. Pancakes-Bacon-fruit-coffee-juice-water-hot water for tea/hot chocolate *All of this looks good. add an assortment of pastries, use judgement based on what kinds of food are available when shopping*

- a) Fun Run Report Only- *The Fun Run will be March 4. The committee will contact all past sponsors as well as many new ones to get the word out. 30+ volunteers are needed to work along the course on the day of the run.*
- b) December fundraiser? See's Candy or Family Movie Night? *Discussed the December fundraiser. Consensus was to do a See's Candy Fundraiser at Gold Trail only, and to do a Polar Express themed Pancake Breakfast at Sutter's Mill. A motion to approve the above discussed fundraisers was made by C. Fanning, Second by B. Poulson. All Approved, motion carried.*
